CALL TO ORDER

Mr. Arciniega called the meeting to order at 12:04 p.m.

APPROVAL OF AGENDA

Mr. Arciniega called for consent to approve the Associated Students UCLA Board of Directors' Services Committee August 8, 2019, Agenda. There being no objections, the motion was approved by unanimous consent.

EXECUTIVE DIRECTOR'S REPORT

Mr. Abbassi reported on the following items:

- An architect has been selected for the UCLA Law School expansion conceptual project. There is no funding for the project at this time. LuValle commons is in the scope of the project. ASUCLA was included in the evaluation and selection committee and has iterated what is needed for the current spaces and possible additional services.
- Wescom Student Terrance and Branch will be open by fall quarter.
- Mobile Food Ordering pilot project for North Campus will launch in the fall.

NEW DIVISION LOGOS

Mr. Baron shared the new ASUCLA division logos to the committee.

ACADEMIC TESTING MATERIALS

USAC President, Robert Watson has committed \$15K surplus funds plus a matching grant from student affairs for a total of \$30K to distribute free academic testing materials to students. Students will need their Bruin Card to obtain blue books and there will be a limit of two per transaction.

ESPORTS PRESENTATION

Ms. Zimmerman and Mr. Rivers gave a presentation on an esports gaming lounge at North Campus.

POTENTIAL CONCEPTS FOR A&B LEVEL BOOKS

Mr. Healey explained that the gift area would move to the gift and general book section to make way for lounge space for students. A-level will have a lounge or pop-up in the central area during the quarter (after fall rush).

ANDERSON CAFE

The Café is open and there will be a grand opening in September. Café sales are slow; however, the unit does not have all the equipment and is addressing electrical issues. Ms. Bolton stated the café is now buying their bread goods from Housing and Hospitality.

MISCELLANEOUS

Mr. Healey explained that shrinkage in the Store has increased since the paper bag implementation. The Store is proposing to change out the bags to recycled and reusable plastic bags which will be free of charge.

EXECUTIVE SESSION

Mr. Arciniega called for consent for the Associated Students UCLA Board of Directors' Services Committee to enter into Executive Session. There being no objections, the motion was approved by unanimous consent.
